Report of election results:

1. Within 30 days after the declaration of official election results under section 98 for an election by acclamation or under section 146 for an election by voting, the chief

election officer must submit a report of the election results to the local government.

2. In the case of an election by voting, the report under subsection (1) must include a compilation of the information on the ballot accounts for the election.

BACKGROUND:

Section 158 of the *Local Government Act* requires the Chief Election Officer to submit a report to Council within 30 days after the declaration of official election results.
